Public Participation

RATIONALE:

This policy is intended to promote open and transparent governance of the Village. The Village of Boyle values and encourages public participation and is committed to open, two-way communication to develop and deliver quality programs and services that meet the needs of the community.

PRINCIPLES:

- 1. This policy applies to public participation which may be influenced by legislation, annual budget, emergency situations, timeframes, types of notification and degree of potential impact on affected parties.
- 2. This policy applies except where:
 - a) Participation is otherwise prescribed by statute or regulation;
 - b) Subject matter is deemed minor in nature and council has authorized that no public engagement is required.

GUIDELINES:

Goals for communication and public engagement will

- 1. Lead to greater satisfaction and better relationships with citizens.
- 2. Reduce complaints and concerns that arise late in the process.
- 3. Lead to better solutions and decision making.
- 4. Provide residents an opportunity to be involved in decisions that may impact their community.

PROCEDURE:

- Council will communicate and engage citizens to allow for input throughout the decisionmaking process for events identified in this policy.
- 2. The event will determine the type and level of engagement. The events will be listed in Schedule "A".
- 3. If two types of engagement are identified in Schedule "A", Council will determine the type required.
- 4. The process of engagement that Council can select is listed in Schedule "B".
- 5. Council will communicate back to the public after a decision has been made.
